## Explanatory notes

### Allocation ownership

The holders of the allocation account nominated in this application will be the owners of all allocation in that account. This includes all allocation traded into the account through this application, and future allocation derived from all water shares linked to the account.

### Place of take approvals

**Note: Notional rationing rate under Section 3(1) of the *Water Act 1989* is referred to as 'extraction share' in this form**

As part of this application, the holder of the allocation account nominated in Section A is applying for an approval to take their water at each service point (pump or outlet) linked to the water-use licences or registrations listed in Section C. This *general place of take approval* (GPT) authorises the ABA holder to take water from the identified approved place (at the service point), subject to any terms and conditions on the GPT.

If you are a river diverter, your GPT will also include your extraction share (ML/day):

- The extraction share is the basis on which restrictions will be imposed when river restrictions are required, meaning that if restrictions are in effect on a river reach, the proportion of a holder's extraction share they are authorised to take during that period will be announced.
- During periods of normal river flow, the extraction share does not constrain the holder's right to take water.
- It's an offence to fail to comply with an announced river restriction.
- In uncapped areas, you may apply for extraction share to be issued to your GPT via a Form 14 (Vary Extraction Share) in line with your annual use limit and subject to Ministerial Rules.
- In capped areas, no new extraction shares will be issued. This means that to obtain extraction share you will need to source and apply for the transfer of extraction share (Form 16), subject to assessment in line with Ministerial Rules.

If you are a district user, your GPT will not include an extraction share as your delivery share is used to manage restrictions if needed.

Holders of a GPT may also be subject to prohibitions in prescribed circumstances. For example, the taking of water from one trading zone that is 'tagged' for use in another trading zone is prohibited when allocation trade between those zones is prohibited.

As a part of this application, any GPTs related to the allocation accounts inactivated in Section D will be cancelled. If the GPT has a non-zero extraction share, prior to the cancellation the water corporation will notify the holder of their options to transfer or cancel the extraction share.

### Minimising the overall application fee to be charged

The application fee is equivalent to the current allocation trade fee for each water share and for each water-use licence / registration added to the allocation account. In addition, each allocation trade also attracts an additional allocation trade fee. Therefore, the allocation account you nominate can impact the overall application fee. You may wish to confirm with your water corporation how the overall fee can be minimised.

### Water shares that may be included

Only water shares with trading zones that are the same as the nominated allocation account can be included. Contact your water corporation if you are unsure that the water shares trading zone is the same as the nominated allocation account.

**Who must sign this application form?**

This application must be signed by:

- All owners of each water share being added to nominated allocation account;
- One of the holders of each water-use licence/ water-use registration being added to allocation account;
- All of the holders of the allocation accounts where allocation trades have been nominated; and
- All holders of the nominated allocation account.

This is necessary because:

- The water share owners are giving the future allocation from their water shares to the holders of the nominated allocation account ;
- At least one holder of each water-use licence/ registration must consent to the use of that water on their land;
- The holders of the allocation account(s) or their authorised agents are applying to have their remaining allocation balance transferred to the holders of the nominated allocation account; and
- The nominated allocation account holders are applying to have additional water shares and/or water-use licence/ water-use registrations linked their account.

Each person only needs to sign once, even if they own more than one water share and/ or are a holder of more than one water-use licences/ registration or applying to trade allocation from more than one allocation account.

If a water share owner or a water-use licence/ registration holder is a company, two directors or one director and secretary are required to sign. An ASIC company extract less than 12 months old must also be attached. A company extract is available from [www.asic.gov.au](http://www.asic.gov.au).

If a water share owner or water-use licence/ registration holder is an incorporated association, the listed secretary is required to sign. An incorporated association extract that is less than 12 months old must also be attached. An incorporated association extract is available from [www.consumer.vic.gov.au](http://www.consumer.vic.gov.au).

**Holders and authorised agents of the allocation account**

This application does not change the allocation account holders or authorised agents.

**Rescinding any link created by this application**

To rescind this approval for a given water share or water-use licence/ registration, the respective owners must apply to link the water share or water-use licence/ registration to another allocation account. This is done via an application to transfer or vary the water share (a Form 1 or Form 9 application), or via an application to vary the water-use licence/ registration (a Form 24 application).

**What is happening under the Water Act 1989**

This form is an application, where applicable, for the Minister's approval to:

- give a water allocation assignment (under section 33X);
- give a standing assignment (under section 33TA);
- revoke a standing assignment (under section 33TB);
- obtain a general place of take approval (under section 64FC); and
- obtain a particular place of take approval (under section 64FZJ).


This form may also be a notification to the Minister that you have removed consent for ABA holders to use water on your land, and this information can be used by the Minister to cancel ABA holders' general place of take approvals (under section 64FS(2)). The revoked ABA holders that hold extraction share will be notified before their general place of take approval is cancelled.
