Explanatory notes

This application is to vary a water share. This allows the water share owner to:

- Change the allocation account (ABA) linked to their water share;
- Change the water use licence(s) and registration(s) formally associated with their water share; and
- Formally disassociate their water share from water-use licences and registrations;

Changing the Allocation Account (ABA)

The proposed ABA must have the same source trading zone as the water share, and the same water corporation reference as the water share. If you are linking an ABA that you are not the holder of, you are giving the future allocations from your water share to the person named on the ABA. This is known as a standing direction.

A standing direction can be revoked by changing the ABA linked to the water share.

Cancel Formal Association with Land

This application can be used to cancel the formal association of the water share with a water-use licence and registration (WUL/R).

If the formal WUL/R associations with the water share are cancelled the water share becomes disassociated from land. In that instance the water share will have a delivery system of 'non-water user' (NWU).

However, the disassociated water share can still be used on the land by having the WUL/R linked to the water share's allocation account (ABA).

Changing the Water Share's Formal Associations with Water Use Licences and Registrations (WUL/R)

This application allows you to nominate WUL/Rs you wish to formally associate with your water share.

To formally associate a water share, the water share owners must also be owners or occupiers of the land or related to the land owner. A water share cannot be associated if it would exceed the WUL/R's holding limit.

Tagged Accounts

Tagged accounts means a water share is linked to an allocation account (ABA) where the use trading zone is different to its source trading zone. In all instances the ABA's and the water share's source trading zone must be the same.

Water shares can be linked to an ABA with different use and source trading zones by:

- Directly linking the water share to the ABA without formally associating the water share to any water-use licence or registration; and
- Formally associating the water share to a water-use licence or registration with a use trading zone that is different to the water share's source trading zone.

You need to be aware that in both instances the ability to use the allocation from the water share may be restricted by trading rules. Contact your water corporation for more information.

Who Must Sign this Application Form?

- In all instances all the water share owners must sign.
- If the application associates the water share with water use licences (WULs), one holder each of the respective WULs must sign.
- If the application is to revoke the water share association only the water share owners sign.
- If the application is to give a standing direction or revoke a standing direction only the water share owners sign.

If the Water Share Owner is a Company or Incorporated Association

- Companies must attach an ASIC company extract that is less than 12 months old. Two directors or one director and secretary are required to sign.
- Incorporated associations must attach an incorporated association extract that is less than 12 months old. The listed secretary is required to sign.

What is happening under the Water Act 1989

This form is an application, where applicable, for the Minister's approval to:

- associate the water share (or revoke its association) with a water-use licence or water-use registration (under section 33AQ);
- give a standing direction (under section 33TA);
- revoke a standing direction (under section 33TB);
- approval to use water from the water share on land which the water share is not associated (under section 64 K).

Water share copy of record

A copy of the Water Share' record (copy of record) can be purchased from www.waterregister.vic.gov.au. The copy of record provides full details of the water share including its ownership, volume, water system, trading zones, reliability, water corporation reference and encumbrances that may be recorded against it like mortgages and limited term transfers.
